# Course Introduction

## Rehabilitation of the Edentulous and Partially Edentulous Patient

This three-day educational activity will demonstrate full and partial denture fabrication. It will provide you with the information and skills to treat more complex cases than you may have experienced prior to this class, with renewed confidence. In this course the use of the Myomonitor and K7 will be demonstrated to simplify full and partial denture fabrication. It will give you the information and skills to provide the most comprehensive care for your edentulous patients. This program will clearly identify the LVI Global neuromuscular perspective of beautiful form following excellent function. Although there are over 20 million edentulous patients in the U.S., this is often a neglected area of dental service. The course includes a clinical demonstration of every detail of full and partial denture fabrication - from initial exam and diagnosis to denture delivery and adjustment. The instructors will demonstrate the skills and knowledge to successfully and predictably deliver a premium prosthetic service.

- How to make the muscles work for you for maximum denture retention
- Myomonitor bite registration techniques
- K7 denture bite registration techniques
- Four easy, logical steps of neuromuscular denture delivery to minimize post delivery adjustments
- Secrets to partial design: clasp and attachment design. Keep it simple!
- Neuromuscular impression techniques for partial dentures

Change/Cancellation/Postponement Policy:

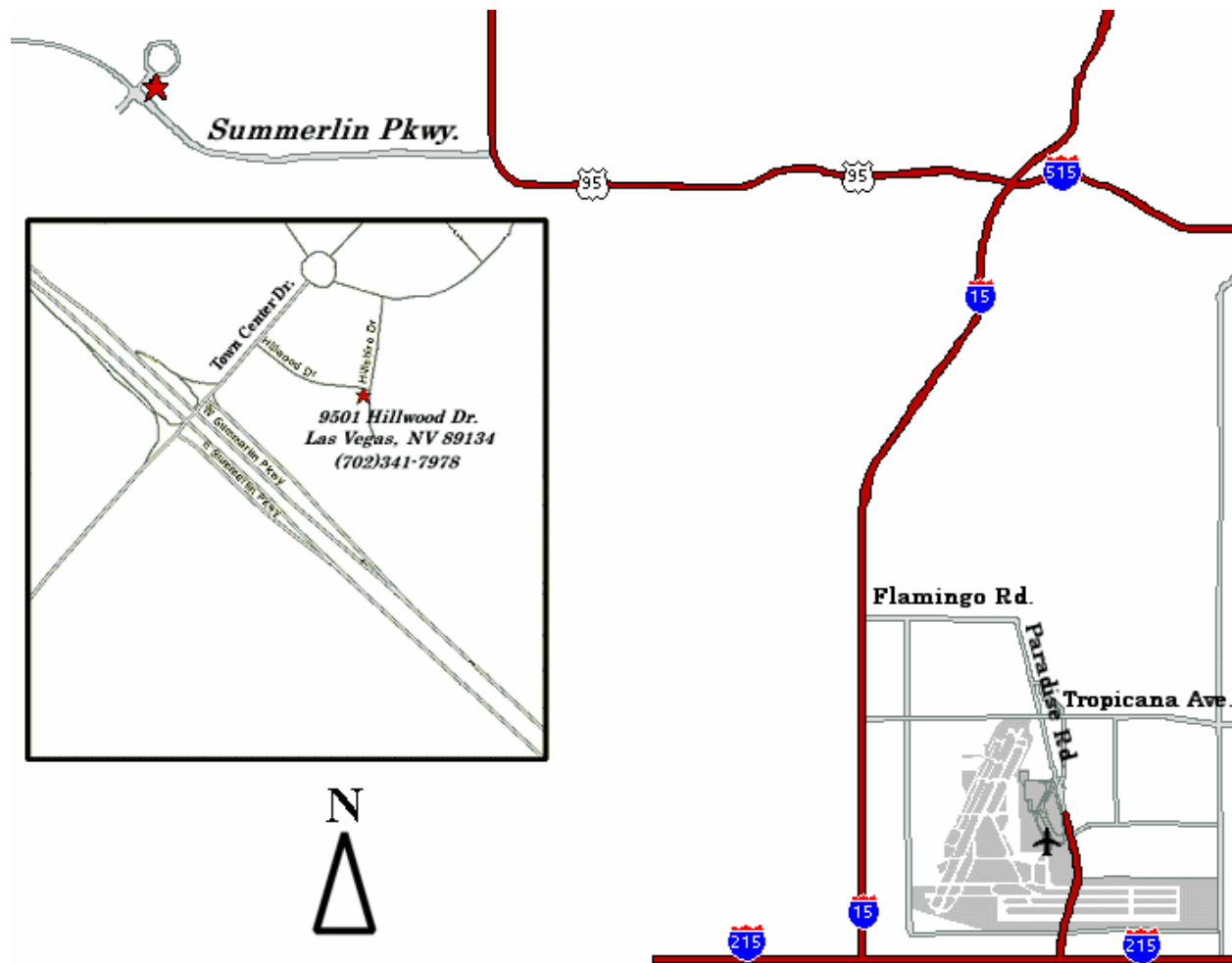
- A change, cancellation or postponement of course date is not complete without your required signature and date.

## Frequently Asked Questions

**Q: What is the weather like in Las Vegas?**

**A:** In the winter months (December through mid-March) temperatures range from lows around 15° with highs up to 60°. In spring (mid-March through May) the weather is nice with highs between 70-80°. Summer months (June through mid-September) are hot, highs up to 110°, with nice warm summer nights. In the fall (mid-September to November) it cools down with temperatures back around 70-80°.

**Q: What should I wear when I come to LVI?**

**A:** Business casual. We tend to keep the building cool, so you may want to bring a light sweater.

**Q: Is food served at LVI?**

**A:** A continental breakfast is served at 7:00 each morning and lunch is provided each afternoon.

**Q:** **How far is the Las Vegas Strip from LVI?**

**A:** Approximately 12 miles. It could take up to 30 minutes with traffic.
