
- Doctors should bring at least one case to be discussed during the course. Records to be included
  are facial series photos ( frontal/lateral 1:10; 1:2 frontal and lateral smile; retracted
  frontal/lateral/occlusal arch views); models with HIP captured; lateral ceph and Sassouni
  analysis preferably with and without myobite in place; Physiologic bite preferably models
  mounted on Stratos articulator with maxillary cast mounted to HIP.
- If you own a K7, the following scans would be useful but are not required to review a case: scan 2,3,11,13,16,9 rest/co, 10 rest/co
- Each doctor should bring plaster/stone models of their own upper and lower teeth
- Each office will need to bring the following items. The instruments can be purchased through
   Five Star Orthodontics 1-800-521-2351

If you already have a bracketed typodont from a previous course, there is no need to buy a new one. Please bring it for the hands-on exercises. We do not have extra typodonts to provide at the course.

- An articulated Typodont without braces (320-0032) (One Typodont per participant is ideal however it can be shared by the office if needed. If sharing a Typodont please also bring: one Mathieu plier and one Pro 90 ligature remover per Typodont)
- Upper and Lower 5x5 brackets to be placed during the course
- o Bands for all 4 first molars
- Mathieu plier (151-0534)
- o Pro 90 Double Ended Ligature Director/Remover (151-0093)
- o Pin and ligature cutter (151-0542)
- Distal End Cutter (151-0156)
- Band pusher (151-0107)
- Bracket placer (151-0185)
- o 12 inch ruler

# What is the weather like in Las Vegas?

In the winter months temperatures range from 15-60°. In spring the weather is nice with highs between 70-80°. Summer months are hot, highs up to 110°, with nice warm summer nights. In the fall it cools down with temperatures back around 70-80 degrees.

# What should I wear when I come to LVI?

Business casual. We tend to keep the building cold so you might want to bring a light sweater.

#### What should I wear if I am treating a patient in the clinic?

Just as you would in your office, appropriate Clinical Attire is expected at LVI. Attire should conform to OSHA/CDC guidelines and regulations, and should include protection like closed toed shoes for all of the team in the clinical setting.

#### Is food served at LVI?

A continental breakfast is served at 7:00 each morning and lunch is provided each afternoon. Snacks are also available throughout the day.

## How far is the Las Vegas Strip from LVI?

Approximately 12 miles. It could take up to 30 minutes with traffic.

#### Do you provide transportation to LVI?

LVI provides transportation *only* from The Red Rock Hotel and JW Marriot Hotel. Check with the Bell Stand for pick up times on course days.

#### Where do I check-in when I first arrive at LVI?

For every course you attend at LVI, you must check-in on the first day in the Hillwood Building (Building with the purple rotunda). You will be directed to breakfast at registration.



# How many CE hours can I expect to receive from this course?

- Utilize T.E.N.S. to stabilize occlusion before, during and after orthodontic treatment to achieve an optimal physiologic occlusion.
- Complete a hands-on bracket placement exercise.
